- As an indication, for a Senior Consultant role, at least five years of relevant professional work experience would be expected to provide the necessary experience. For a Principal Consultant role at least seven years would be required.

- Experience in national and/or international environmental policy in at least one of following topics: climate change, chemicals, circular economy, air quality, industrial emissions, waste and/or water.
- Experience undertaking policy / programme evaluations and/or impact assessments and/or cost benefit analysis and or applying techniques to place monetary values on externalities.
- Experience of working in/with UK Government (and/or their agencies), another national government or agency and/or an international body such as the European Commission.
- Experience in assessing the relationship between environmental policy and competition, competitiveness and innovation.
- Proficiency in other EU language(s).
