- Fluency with EIA Socio-Economic/Population chapters. Particularly the social impact assessment element. The economic calculations are desirable, but training on this can be provided.
- A passion for improving community social outcomes across diverse projects and settings.
- An acceptance that the role must engage with some difficult and controversial issues at times and we will not be able to secure ideal outcomes in every case.

- Experience and/or interest in supporting delivery of health and equality impact assessments.
- Self-discipline to be in a remotely managed team, strong project management skills and ethos to be an active positive team player.

Qualifications:

- MSc or core qualification in the social sciences such as sociology, anthropology, economics, human geography, or development studies.
- The methodological skills, contextual experience and ethical orientation to assess and interpret social change, including through participatory approaches.
- Core competencies include the ability to apply mixed research methods, understand power dynamics and cultural norms, and engage in dialogue with affected communities.
- Membership of relevant professional institutions, e.g. ISEP.
