- Climate change strategies and action plans, working with clients to prepare their approach to net zero, underpinned by specific and measurable targets to reduce carbon emissions.
- Decarbonisation planning and project support including buildings and energy, transport and industrial processes to enable action to reduce emissions.

  - Working with clients on their TCFD actions and developing approaches and reporting disclosures, aligning to the TCFD recommendations.
